After considering the submissions made and the result of the post-race veterinary examination the greyhound was issued with an endorsement for Failing to Pursue the Lure first offence under GAR124 and will be subject to a 28 suspension from racing at Wagga and will be required to complete a satisfactory Stewards trial in accordance with GAR132 before being eligible to nominate again.

The judge and Stewards declared a dead heat between RUN BLUE RUN and XIRA BALE for second place.

1 Douglas Dash	Pre-race sample collected. Stewards noted that the greyhound had been well supported in betting and interviewed the trainer who stated that their runner is well boxed and the kennel has mildly supported there runner. The trainer presented the greyhound to the OTV for a post race veterinary examination revealing a off-side hind toe fracture. A 60-day incapacitation period was issued.
5 Scathing	Checked off heels on the 1st turn and then was galloped on from behind and fell, severely hampering other runners. A post-race veterinary examination was carried out revealing a fractured near-side hind tibia. A 90-day incapacitation period was issued. The greyhound has been transported to a veterinary facility for further treatment
